Message from Director

Interagency and transnational co-operation continues to be a recurring theme through this edition of Probation works. All of the agencies in the Criminal Justice System, and beyond, have a role to play in reducing crime. We all add to our own unique value, and to that of our partner organisations, when we work positively together. There are some exciting conference opportunities in the coming months - see below, where mutual understanding and effective interagency co-operation can be further developed.

We continue to further develop group and individual programmes in the Probation Service to help offenders reduce their risk of reoffending. We have revised, updated and

piloted our new Choice and Challenge offender programme manual, which is now being rolled out in practice. We are also continuing our priority focus on Community Service and welcome the recent launch by Minister for Justice and Equality, Alan Shatter of two new graffiti project buses.

There have been some significant new appointments in Northern Ireland recently. Congratulations to Cheryl Lamont, who has been appointed as (Acting) Director of Probation with the Probation Board for Northern Ireland (PBNI). This appointment follows the move by former PBNI Director Brian McCaughey to a new post of Director of Rehabilitation with the Northern Ireland Prison Service. We wish both Cheryl and Brian well for the future.

In Britain, there have also been two significant appointments announced. Mr. Mike Maiden has been appointed Director of the new National Probation Service, while Ms. Sarah Payne will become Director of the National Offender Management Service (NOMS) for Wales. Mike and Sarah are due to take up their new appointments in April 2014, as part of the 'transforming rehabilitation' reforms in Britain. We look forward to continuing to develop our already excellent working relationships with all our colleagues in neighbouring jurisdictions.

Minister launches new Community Service Graffiti Removal Buses

Minister for Justice, Alan Shatter TD, along with the Director, recently launched two new custom-designed and purposebuilt buses for Dublin and Cork, to carry both those on Community Service and Community Return, their Community Service Supervisors, and all the necessary equipment for graffiti removal.

This investment by the Department of Justice and the Probation Service is a strong

endorsement of the value of these projects, run in co-operation with the various Local Authorities.

Last year, 145 offenders completed their Community Service/Community Return on the graffiti programmes, providing a valuable neighbourhood-improving service in Dublin and Cork.

Offending Behaviour Groupwork Programme Manual Developed

The Probation Service has been using a range of offender programmes, which target key factors linked to offending and help offenders to reduce risk of further offending, and based on 'What Works' principles, over many years. These programmes are targeted at offenders who have been assessed by Probation Officers as being at medium to high



risk of reoffending. Over the past year, our Programme Development Unit (PDU) in collaboration with the Bridge Project, based in Dublin, updated our Choice and Challenge programme and this month launched the revised and updated programme manual for use by Probation Officers and our project workers.

The Choice and Challenge programme facilitates participants in challenging negative beliefs and attitudes, encourages the development of pro-social attitudes and behaviours, and helps them to use positive problem-solving methods, and promotes personal growth, development and responsibilisation. The PDU/Bridge Team are now working with a range of front-line Probation teams to deliver the new Groupwork programme, as well as developing a one-to-one version of the programme, for use with offenders for whom group programmes are not feasible. Choice and Challenge is a core probation intervention and this updated version significantly strengthens our capacity in helping offenders to remain crime free.

The Probation Service in Numbers

9,025 offenders being supervised and/or assessed in the community by the Probation Service as of 15th August 2013.

2,087 people on Community Service nationally, on 15th August 2013.

1,053 the number of person-years in alternative (custodial) sentences that would have been imposed on those who were sentenced in 2012 to Community Service instead.

384,159 hours of unpaid work ordered by sentencing Courts to be done by offenders on Community Service in 2012.
