## Message from Director

Earlier this month, I announced that I will retire from my position as Director of the Irish Probation Service at the end of this year. Two obvious questions that present themselves are: why retire? and why now? There is no great mystery in my responses to these questions. I have served as Director since August 2012, having first joined the Service as a Probation Officer in



1987. There is not always, nor necessarily ever, a particularly 'good' or 'bad' time to retire. I did indicate when I took on the role of Director, that I would aim to serve in this post for around seven years, at which point I would review the situation. Having done that (personal review) recently, I recognise the Probation Service has come through an extensive period of change, and is in a relatively good place as an organisation, although there is still more to be done to maximise the potential of the agency. I believe the Probation Service is now at a critical stage of its ongoing development, particularly regarding the continuing evolution and implementation of our Irish probation practice model and framework for service delivery. In that respect, the organisation will benefit from having a new person, new thinking and new energy at this level, to guide it through the coming few years, and I have decided to make way for that person. I am confident that the Service will continue to benefit and build from its well established and solid values and practice base, from the continuing dedication of its management team and

colleagues across the entire organisation, in constantly seeking to build on that solid practice foundation, and to deliver ever–improving services, for better outcomes. I intend to work out my remaining time in my current role in the same way as I have always approached my work – with dedication, urgency and commitment. I will also use this time, in collaboration with my Departmental and Probation colleagues, to ensure, insofar as we can, the smoothest and most effective transition phase to the new leadership, as possible.

The Probation Board for Northern Ireland (PBNI) held a seminar, entitled 'Justice: Improving Outcomes for Communities,' in the Long Gallery of Stormont Parliament Buildings, Belfast, on Friday 27th September. Vivian Geiran, Director, participated at the event, which was attended by politicians, senior justice sector and other governmental and public service figures, as well as members of the Judiciary and academics/researchers, and senior NGO executives, on behalf of the Irish Probation Service. The seminar heard presentations from a range of senior personnel, on the subjects of working collaboratively, to achieve better outcomes for communities. 

## 4th World Conference on Probation in Sydney

World Congress on Probation in Sydney,
Australia on 18th–20th September hosted by
the Corrective Services NSW. CEP, with APPA and
ICPA, have supported the hosting of the WCP

Prof. Fergus McNeill opened the World Congress with an insightful and challenging paper on

in line with recommendations from the Community Return Evaluation Report carried out by the Irish Prison Service and the Probation Service in 2014, as well as the May 2018 report on Penal Reform and Sentencing by the Oireachtas Joint Committee on Justice and Equality. The new criteria came into effect at the beginning of August.

Under the expansion, the qualifying period for Community Return for prisoners who are serving a sentence for a period of between 1 and 3 years inclusive is shortened. Instead of the qualifying period being 50% of the sentence imposed by the Court, it will instead be 50% of sentence as remitted under the Prison Rules.
